This Gran Canaria SSTD 2024 is an International Conference organised by Tides, The Institute of Tourism and Sustainable Economic Development that belongs to the University of Las Palmas de Gran Canaria. #### **Conference venue**

The opening ceremony will be held on the 12th of June with keynote speaker sessions and with the participation of the Canary islands's Tourism Vice-councelor and The Gran Canaria Tourism board manager. Parallel sessions of paper presentation will take place thereafter. After the day's presentations, the delegates will take a walking tour. Expect to enjoy the famous Ocean Avenue in Meloneras: an area surrounded by a fascinating landscape of ravines and protected areas like the golden-sand beach of Maspalomas.

During 12th and 14th of June 2024, keynote speakers, an industry panel discussion, as well as research presentations sessions will take place during the day. On 14th of June, there will be a guided tour to the historical part of the city of Las Palmas de Gran Canaria during the evening and a conference banquet dinner in an emblematic hotel. Best Paper Awards will be given at the banquet dinner. Welcome to our beautiful island!!

On Friday, the 14th of June, we will have our Doctoral event!! This event intends to bring PhD students together with tourism researchers. Students will prepare a 10-minute elevator pitch of their research ideas or works, which will be debated with the Conference keynote speakers. The most innovative presentation will be awarded! The prize event will be held during the gala dinner.

Conference fees include lunch meals in the Baobab Hotel on the 12th and 13th of June, the guided tour to the city center and the closing conference dinner in an emblematic hotel in the city center on the 14th of June. #### **Some of the Conference Keynote Speakers**



**Dae-Young Kim**University of Missouri (USA)

Dae-Young Kim is a professor of Hospitality Management (HM) at the University of Missouri. He serves as the membership secretary of the Asia Pacific Tourism Association (APTA) and as the review chair for the Thesis-in-Progress session at the APTA annual conference.

Dr. Kim's research specialties include tourist destination management, sustainable tourism, traveler behaviour, and cognitive psychology. He has authored more than 180 peer-reviewed journal articles and conference proceedings, which have been published in top-tier refereed hospitality and tourism journals such as Annals of Tourism Research, Journal of Travel Research, Tourism Management, International Journal of Hospitality Management, and Cornell Hospitality Quarterly.

He joined the HM faculty at the University of Missouri in 2006 after completing his Ph.D. (2006) and M.S. degree (2002) in the Department of Hospitality and Tourism Management at Purdue University. Dr. Kim is the recipient of the Fulbright U.S. Senior Scholarship (2024) and the Rotarian Ambassadorial Scholarship (2000).



**Teresa Aguiar Quintana** Universidad de Las Palmas de Gran Canaria (Spain)

Teresa Aguiar Quintana is a Full professor at the University of Las Palmas de Gran Canaria (ULPGC) in the Economics, Business and Tourism Faculty on Gran Canaria island (Spain). She is currently the Vice/President of ITSA (International Tourism Studies Association) in the European Mediterranean area and the Transference and dissemination director of the Institute of Tourism and Sustainable Economic Development (Tides) at the University of Las Palmas de Gran Canaria. She has published academic case study books in Síntesis editorial, and in Routledge and Cambridge Scholars Publishing, and more than 30 book chapters. She has also published several scientific articles indexed in Journal Citation Reports (JCR) like Tourism Management, International Journal of Hospitality Management, Journal of Business Research, Tourism Management Perspectives, Cornell Hospitality Quarterly and Journal of Leadership & Organizational Studies.

Her participation in international conferences is extense and she has worked as a visiting professor with research periods in Surrey University, in the Free University of Bolzano, in Munich Applied Sciences University and in Eastern Finland University. She has also been the Conference Chair of the I, II, III, IV, V and VI SSTD - Spring Symposium on Challenges in Tourism Development organized by Tides in Expomeloneras on Gran Canaria island. She has also been a member of the Scientific and Organizing Committee in several international conferences.

Finally, some of her Research projects are The Pilot project: Kuoni-Towards Travelife, with a partnership between Tides and Leeds Beckett University in the last decade. She also signed a research project with the Canarian Tourism Council about Retrospective analysis in Tourism and, recently, she signed a research project to study strategies for recovery for the MICE tourism after Covid, project funded by the Gran Canaria tourism board in 2021 and 2022.



Maria Lexhagen Mid Sweden University (Sweden)

Maria Lexhagen is professor of tourism studies at Mid Sweden University, Sweden, where she is part of the Etour research center. She obtained her Ph.D. from School of Business, Economics and Law, at University of Gothenburg, Sweden. Her research interests are focused on marketing, tourist behaviour and destination marketing, management and development issues such as customer-based destination branding and value creation, business intelligence in tourism, smart tourism destinations, digital aspects of tourism experiences, and popular culture tourism. She has published in many tourism journals and books, co-edited books and special issues, and is an engaged and frequent reviewer for leading journals in tourism.


