- (1) Deadline for all students, regardless of whether they submitted in previous academic years and wish to present the Master's Thesis (TFM) in any call of the 2025-2026 academic year.
- (2) This deadline must be used by students who have not reached voluntary agreements and plan to participate in any of the calls during the 2025-2026 academic year.
- (3) Any modification of the title and/or supervisor that alters the objectives of the previously submitted work must be accompanied by a new F01 or F03 form.

STUDENTS MAY SUBMIT APPEALS AGAINST THE DECISIONS OF THE TFM COMMITTEE WITHIN TEN BUSINESS DAYS FOLLOWING THEIR PUBLICATION ON THE VIRTUAL CAMPUS.
