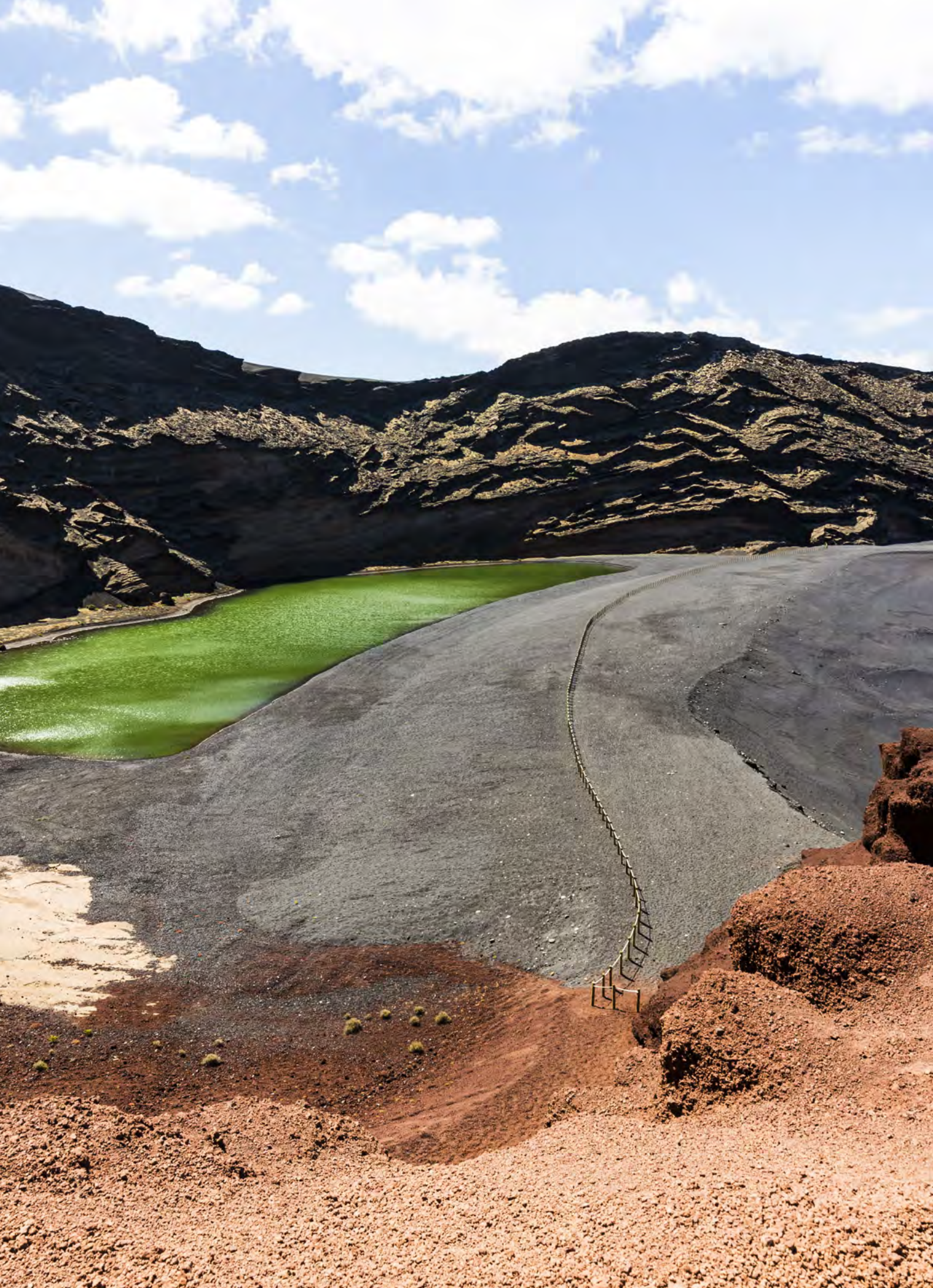

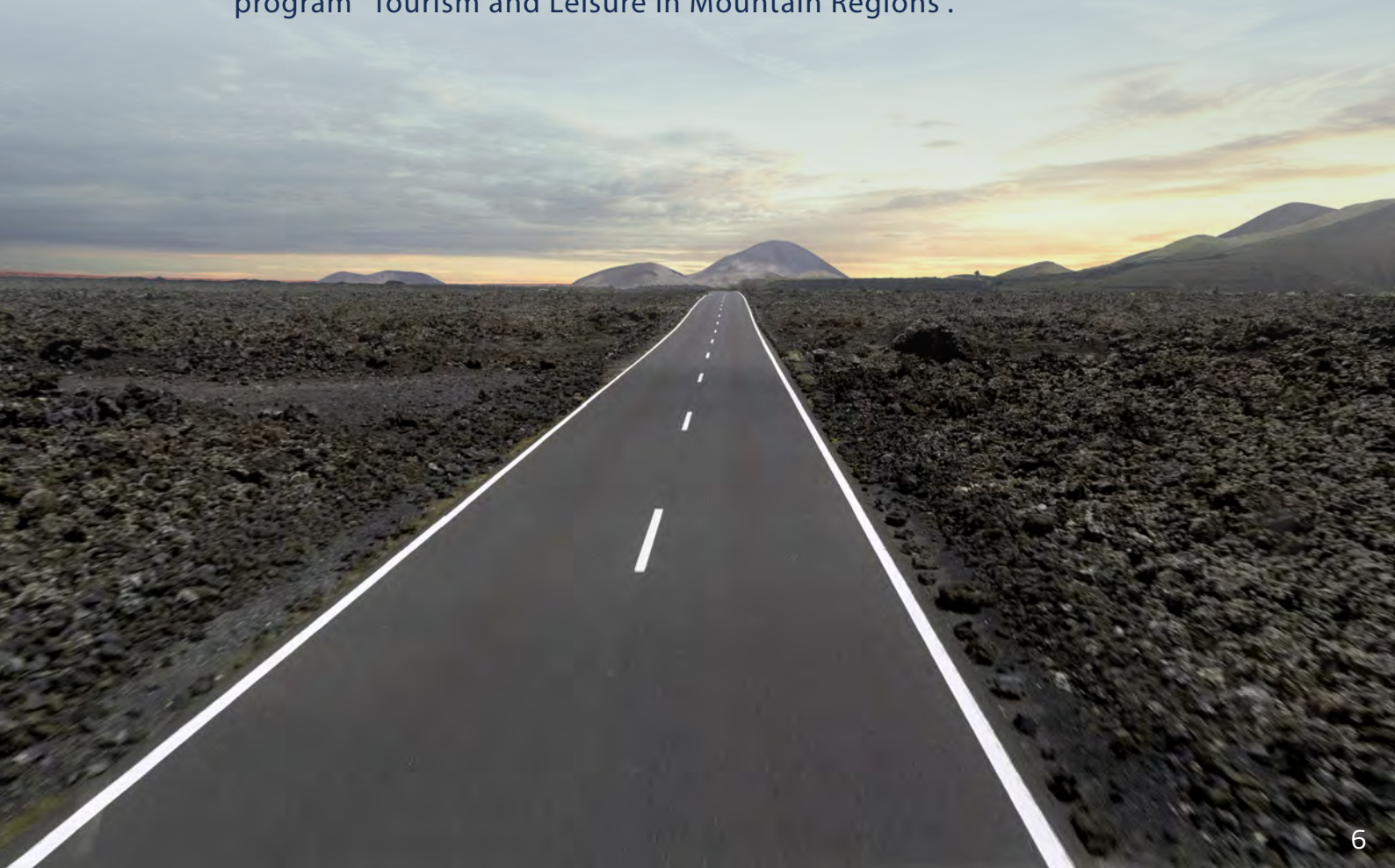

He is the study coordinator of a tourism bachelor's program, and a master's program in sustainable regional development, and deputy speaker of the Doctoral program "Tourism and Leisure in Mountain Regions".
